2017 Glencoe Caucus Slate for Village President and Trustees



Larry Levin, Village President

Larry has been Village President since 2013. Prior to becoming Village President, Larry was a Village Trustee, Vice Chairperson of the Plan Commission, and Chair of several other Village Committees, as well as a North Shore Environmental Commissioner. In the past, among other governmental activities, he has served as Special Counsel to the Village of Glencoe, during Jim Web's two terms as President and as a member of the Village Commercial Task Force and the Village's Special Task Force on Village Economic Development in the 1990s that recommended that the Women's Library Club and the Writers' Theatre join forces.



Barbara Miller, Village Trustee

Barbara is seeking a second term as Glencoe Village Trustee, Vice-Chair of the Plan Commission, and a member of the Finance Committee. Her previous Village offices include leadership positions on the Zoning Board and the Caucus, and membership on the Home Rule Task Force. Trustee Miller's priorities for her next term on the Village Board include implementing the Downtown plan to enhance Glencoe's ability to attract, retain and promote vibrant businesses and cultural institutions, and developing Glencoe as a leader in sustainability.



Gail Lissner, Village Trustee

Gail is seeking her first term as a Trustee. She is a long-time resident of Glencoe and currently serves on the Glencoe Zoning Board of Appeals. She is a Vice President of Appraisal Research Counselors, a Chicago-based real estate appraisal and consulting firm, where she focuses on housing/multi-family market valuation and consulting.



Dale Thomas, Village Trustee

Dale Thomas has long-standing family ties to the Chicago area. A 27-year resident of the Village, he is a member of the firm of Sidley Austin LLP who holds both a law degree and a divinity degree from Yale University. His professional experience has focused on telecommunications and energy regulation. In his free time, he is continually striving to upgrade his golf game – primarily at our beautiful Glencoe course.

What is the Glencoe Caucus?

Since 1936, the Glencoe Caucus has run a non-partisan slate of candidates in every election. The caucus consists of our neighbors, elected to serve our community in the solicitation, vetting and diligent selection of qualified and respected residents as candidates whose principal interest is the welfare of Glencoe. Many past candidates and trustees would not have considered running for public office if it were not for the Glencoe's depoliticized process. Any resident of Glencoe for a minimum of 2 years and is registered to vote may run to serve on the Caucus or apply to the caucus to be interviewed and considered for nomination to any of the four boards. This Caucus system is why Glencoe has a proven and consistent track record of excellent governance in our town.

We encourage you to vote for the Caucus slate in the upcoming election. Good government needs an involved electorate, whether it is on the Caucus, as an applicant to the Caucus, or as a voter.
